#### BORI WITHIN THE CONTEXT NIGER DELTA'S STRUGGLE AND DEV

- Bori is the traditional headquarters of the Ogoni people.
- Bori serves as a commercial centre for the Ogoni, Andoni, Opobo Annang and other ethnic nationalities of the Niger Delta.
- Bori is the host of the Rivers State Polytechnic
- The Bori Urban Area has many adjoining communities, including; the Brave Bua Kaani, Yeghe and Bo-Ue people.
- The Kaani people built and donated the first community secondary school in Nigeria to the Government of the Old Rivers State of Nigeria and part of Rivers East Senatorial District


# REVAMPING THE SOCIAL AND ECONOMIC INFRASTRUCTURES OF OGONI PEOPLE

- History of the Niger Delta's indigenous people cannot be complete without critical reference to Ogoni people
- Ogoni axis is a test-case for any human capital development in the region, which should begin within the flank of Bori in Rivers and Kaiama in Bayelsa, catapulting across other clusters in the region.
- If the ogoni axis does not see infrastructural revolution and meaningful regional development, the talk about developing the Niger Delta is still a huge joke
- GSM handsets production firms and auto manufacturing companies should be encouraged with incentives to set up factories in Bori and other clustering communities, with Gas Incentive tie to fire up power generation for these industries, which should be inputted in the agreement for any oil firm acceptable to the people before resumption of extractive activities in the Ogoni axis.

# COMMUNAL ACCOUNTABILITY AS A YARDSTICK FOR CONFLICT REDUCTION

- Niger Delta communities must indoctrinate transparency and accountability in the running of communities and larger family affairs to deepen the value for governance transparency, which should start at the family and community level.
- If people insist on running community and family affairs secretly, that dishonourably, would make them extend the lack of transparent conduct about *good and services* they are privilege to handle for the larger community with hoodwink spirit, which hitherto could spark off communal crisis and family squabbles in the long run.
- We all must learn and accept to be truly open, transparent and accountable for collective communal and societal good

#### WHAT OF SECTOR SPECIFIC INDICATORS

- In the "Abridged Factsheet" in your hand, there are 10 capital projects for the Bori Cluster.
- In the 2015 Town Hall Master-List, there are 46 capital projects from the Rivers State Budget 2013. Further, NDDC has 87 capital projects and 8 Federal projects.
- These are all projects that affects lives of people.
  However, having the envelopes in the budget does not
  mean it would be cashed back, hence the need for
  stakeholders' follow up at appraising, if there was fiscal
  accident.
